Treasurer Role Description

About NAM:

NAM is one of the world's foremost providers of information on HIV and AIDS. Our information is aimed at two main audiences: people living with HIV; and healthcare professionals. NAM's trustees play a crucial role in advancing the charity's purposes, overseeing the organisation's strategic direction and protecting its assets and interests.

Specific responsibilities of the treasurer:

The specific responsibilities of the treasurer are to:

1. Guide and advise the board of trustees in the approval of the budgets, accounts and financial statements
2. Review and discuss the management accounts and recommended budget changes with the executive director and business manager prior to the regular bi-monthly board meetings
3. Present the bi-monthly management accounts to the board of trustees for their approval
4. Review and discuss the proposed annual budget prior to the special board meeting that approves the budget (usually December)
5. To present the annual budget to the board of trustees
6. Keep the board informed about its financial duties and responsibilities.
7. To work with the executive director and business manager to shape the financial strategy of the organisation
8. Advise the trustees and the management on the financial implications of the organisation's strategic plans and key assumptions included in the annual budget
9. Confirm that the financial resources of the organisation meet its present and future needs and that there are appropriate reserves and investment policies.
10. Understand the accounting procedures and key internal controls to assure the board that the charity's financial integrity is sound
11. Ensure the accounts are properly audited and that accepted recommendations of the auditors are implemented
12. Formally present audited accounts to the board of trustees drawing attention to important points either in a written report or orally
13. Ensure compliance with Companies House and Charity Commission regulations in financial matters for the charity
14. Be an authorised signatory on all of NAM's bank mandates

Time commitment: Approx 10 hours every 2 months.

NAM's trustees' meetings are held alternate months at Acorn House, near Kings Cross, London.

What are we looking for?

Essential:

1. A recognised accountancy qualification
2. Financial and executive level managerial experience commensurate with an organisation with a turnover of £500k pa
3. Experience in budget setting and monitoring
4. Skills to analyse and interpret financial data
5. Skills to analyse proposals and examine their financial consequences
6. Skills to manage change
7. Ability to present financial information clearly, and make it understandable for non-finance people
8. Willingness and approachability to deal with enquiries from trustees and staff on an ad hoc basis

Desirable:

9. Experience of registered charity finances
10. Knowledge of the third sector's reporting regime and of the Charities SORP
11. Experience working in voluntary or not for profit sector organisations

All trustees will have:

1. A commitment to NAM and its work.
2. An understanding and acceptance of the legal duties, responsibilities and liabilities of trusteeship
3. A willingness to devote the necessary time and effort to the duties of a trustee
4. Strategic vision.
5. Good, independent judgement.
6. An ability to think creatively.
7. The courage and willingness to speak their mind.
8. An ability to work effectively as a member of a team.
9. An ability to adhere to the [Nolan Committee's principles for public life](#).
